WHAT IS THE STATUS OF WAQF PROPERTIES?
The Waqf Board currently controls nearly 900,000 properties spanning 9.4 lakh acres across India, with an estimated value of ₹12 lakh crores. Making them the third largest landowner in India

"This is a progressive bill, we do
not anticipate any hurdles in its
passage... one has to look at the
broader issues that will be
addressed by the bill," said a gov-
ernment functionary, declining to
be named.
Some opposition parties,
including the RJD, SP and AIMIM,
attacked the proposed changes
and accused the government of
interference in personal laws.
"Opposition to the bill is from
those quarters that have vested
interests. The amendments pro-
posed will address the biggest con-
cern, the absolute powers that the
board has to determine what is
their property...the proposed
amendments also address the
issue of gender parity by making it
mandatory to have women mem-
bers as part of Waqf boards," said
the functionary cited above.
Asked whether the government
reached out to the Opposition and
allies, the functionary said the
process of communication had
begun for the bill that also pro-

poses to expand the composition
of the Central Waqf Council and
State Waqf Boards (SWBs), and
make provisions for an online sys-
tem for tracking revenue and
expenditure.
The Waqf Board currently con-
trols nearly 900,000 properties

India, with an estimated value of
₹12 lakh crores, making it the
third largest landowner in India.
According to a note from the
ministry of minority affairs, the
amendments are set to incorpo-
rate recommendations from both
the 2006 Rajendra Sachar Com-
mittee report and the 2008 Joint
Parliamentary Committee sugges-

lis (custodians of Waqf), enhanc-
ing record management, and

The proposed amendments are
expected to make it mandatory for


