(RFQ FOR EMPANELMENT OF FINANCIAL CONSULTANTS FOR MAJOR PORTS)

- 1 **Qualification criteria for empanelment of Consultant – para 5** - the term *“Certificate from Statutory Auditors to be submitted for each Category”* is now changed to *“Certificate from the Statutory Auditors to be submitted for 5.1 & 5.2 above and for 5.3 & 5.4 a certificate from the client for successful completion of assignments mentioned/ certificate from the Statutory Auditors for receipt of full amount of professional fees against the project”*

Further the words **“Port Sector”** in 5.3 & 5.4 would be replaced with **“Infrastructure Sector”**

- 2 **Stage II – Short listing / Scoring Criteria for empanelment of Consultants**

The clause in 6.1 which states *“The applicant should provide details of completed assignments in the last 05 years to demonstrate experience in providing the consultancy service, in the relevant category”* **shall be read as** *“The applicant should provide details of completed assignments in the last 5 financial years (beginning 2011-12) years to demonstrate experience in providing the consultancy service, in the relevant category”*

- 3 **Stage II – Short listing / Scoring Criteria for empanelment of Consultants**

The second half of 6.1.1 has been changed from *“For each assignment, the applicant should provide Completion certificate from the client detailing therein – the description for the nature of consultancy provided, the client’s confirmation for the satisfactory completion of work, cost of project, total fees paid, against the assignment, date of start and completion of work. Only after receiving the client’s completion certificate along with all abovementioned details would the bid be considered for evaluation”* **to the following:**

“For each assignment in Categories 1, 2 & 3, the applicant should provide Completion certificate from the client detailing therein – the description for the nature of consultancy provided, the client’s confirmation for the satisfactory completion of work, cost of project, total fees paid, against the assignment, date of start and completion of work. For Category 4 the applicant should provide Completion certificate from the client detailing therein – the description for the nature of consultancy provided, the client’s confirmation for the satisfactory completion of

work, amount of funds raised for the client, date of start and completion of work. Only after receiving the client's completion certificate along with all abovementioned details would the bid be considered for evaluation

In case the completion certificate is not available from the client, certificate from the Statutory Auditors for receipt of full amount of professional fees against the project”

4 **Qualification criteria for empanelment of Consultant - para 5 - Similar Works**

In Similar Works box, the words “**MAJOR PORTS**” is replaced with “**PORTS / INFRASTRUCTURE SECTOR**” to broad base the experience criteria as per request of bidders.
