**Terms and Conditions:**

1. Interested Parties may submit their highest price for the vehicle in a sealed cover latest by **03.30 p.m on 25.01.2023**. The inner cover containing quotations and other relevant documents along with DD/Pay Order towards Earnest Money Deposit (EMD) amount of Rs. **5000/-** ( Rs. Five Thousand only) in favour of Indian Ports Association should be sealed properly. This cover shall be dropped in box kept ~~at~~ Reception of IPA, NBCC Place South Tower 1<sup>st</sup> floor, New Delhi. Cover should be superscripted in bold Capital letters **"QUOTATIONS FOR DISPOSAL OF OLD VEHICLE OF IPA"**

2. The disposal of vehicle shall be strictly on **"AS IS WHERE IS BASIS"** and no guarantee or certificate of its worthiness or quality will be given by Indian Ports Association (IPA). The condition of the vehicle can be inspected physically from **20.01.2023 to 25.01.2023 between 09.00 a.m. to 03.30 p.m at 'Rest House Indian Ports Association, 19, Institutional Area, Lodhi Road, New Delhi-110003.'**

3. If the highest tenderer/successful tenderer accepted by the competent authority in this Department fails to deposit the sale price within the prescribed time limit i.e. within 7 working days from the date of intimation to the tenderer(s) declared as highest bidder by the competent authority then the EMD of that bidder shall be forfeited.

4. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Ration Card/ Voters

Identity Card in case of individual and Registration Certification in case of firms etc.) The sold vehicle will be removed by the successful bidder(s) within two days from the date of intimation to the tenderer(s) declared as highest bidder by the competent authority. No assistance/transportation will be provided by the IPA.

5. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously and submit the copy of the transferred RC. It will be the sole responsibility of the buyer for getting the necessary paper works done in accordance with the law and as per the provisions of the Motor Vehicles Act (amended from time to time) applicable for Transport Authority of Govt. of NCT of Delhi. This office will not be responsible for any lapse on the part of the buyer in this regard.
6. Indian Ports Association reserves the right to reject all or any tender in whole or part without assigning any reasons thereof.
7. The bidder is required to reveal his full name/name of the authorized signatory of the firm/name of father, full postal address, telephone number & mobile number and submit PAN card & Aadhar card etc.
8. Disputes, if any, shall be subject to jurisdiction in the Court of Delhi only.
9. If the highest quoting firm fails to honour the bid; the contract will be cancelled & next highest bidder shall be offered. In such an event, an opportunity shall be given to the next highest quoting eligible tenderer (H-2 quoting party) to complete the bid provided it is prepared to accept the prices offered by the H - I party. In case of any dispute, decision of the IPA shall be final.
10. Tender offer form should be signed in ink by the authorized signatory only. Photocopy or unsigned quotations or quotations not signed by authorized signatory shall be rejected. Tendering firm shall alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.
11. Quotation should be offered in prescribed form only as given above.
